
### **LEGISLATIVE UPDATES**

# PRIMARY URBAN GENTER DEVELOPMENT PLAN (PUGDP) UPDATE FOR KÄHALA NEIGHBORHOOD

The Honolulu Department of Planning and Permitting (DPP) updates the Development and Sustainable Communities Plans for eight regional planning areas on O'ahu. DPP conducts a comprehensive review of these plans every 5-10 years. In 2024, the PUCDP will be updated, which includes neighborhoods from Kāhala in East Honolulu to Pearl City in Central O'ahu.

DPP drafts the initial plans for the PUCDP. These plans are then reviewed by the community, revised by DPP, and sent to the Planning Commission for public hearings. After the Planning Commission completes its hearings, it sends its recommendations to the Honolulu City Council in Bill form. The Bill is then adopted by the Ordinance.

Bill 24 (2024): To Adopt the Revised Primary Urban Center Development Plan for the City and County of Honolulu passed its first reading at the April 17, 2024, full Council meeting and has been referred to the Committee on Planning and The Economy.

These long-range plans guide land use planning and development through goals, policies, and actions based on a shared vision for each region developed in collaboration with the community. Your input is important to me, and I will work to prioritize your needs.

I am currently involved in making changes to the Land Use/Place Types Maps for the Kāhala Neighborhood. These maps indicate the various land use designations allowing development and density in each area. As per the PUCDP for Kāhala, it is interesting to note that Kāhala Mall is classified as a "commercial retail center," while the Kū'ono Marketplace, Kāhala Zippy's, Assaggio Bistro, the Kāhala Atrium, Kaimukī-Kāhala YMCA, and Church of the Latter-Day Saints are classified as "Near-Town Corridor-Center Medium." You can find more details on page 44 of the PUCDP.

I am concerned about the designation of the Near-Town Corridor-Center Medium for these parcels. This designation allows for residential and mixed-use buildings of 3-8 stories with commercial spaces on the ground floor and residential units on the upper floors. I am not convinced our community would welcome taller buildings on these parcels. Moreover, the Honolulu City Council is currently working on amending the Development Standards Section of the Land Use Ordinance, Bill 64 (2023): Relating to Use Regulations. The current version of this Bill would permit Kāhala Mall to develop housing above the commercial spaces, like Ala Moana Shopping Center. However, I disagree with DPP's view that the community would want several floors of residential units above Kāhala Mall, even though the height limit is lower in Kāhala compared to Ala Moana.

I am committed to preserving the charm and character of our Kāhala Neighborhood. I don't want the more intensive development to change what we already have. I agree that we need mixed-use development in other areas of the PUCDP but not on the eastern border of the Plan's area.

### **LEGISLATIVE UPDATES**

### **RESOLUTIONS:**

**RESO 24-62**: Urging the City Administration to construct additional beach/sand volleyball courts at City parks. The popularity and talent surrounding beach volleyball on our island have grown beyond the capacity of the available public courts for playing and practicing. There are only six City beach/sand volleyball courts, four at Queen's Beach and two at Ala Moana Regional Park. Hawai'i produces many incredible volleyball players, and it would be fantastic if more spaces were made available for community members who don't have access to private clubs and training to play. However, existing public courts are often reserved well in advance and used from sunrise to sunset. Therefore, additional beach/sand volleyball courts are more necessary than ever. **PASSED OUT OF THE COMMITTEE ON PARKS, ENTERPRISE SERVICES AND CULTURE & THE ARTS** (04/03/2024) for adoption at April full Council meeting (04/17/2024).

**RESO 24-63**: Relating to the Council's Appointment of Cynthia L. McMillan to serve on the City and County of Honolulu Rate Commission. The Rate Commission is responsible for reviewing the fares, fees, rates, and other charges for the use of Skyline, TheBus, and TheHandi-Van and recommending adjustments to ensure that the generated revenues, combined with other allocated funds, adequately sustain the system's operation and upkeep. The Commission may also consider factors like transportation equity, accessibility, sustainability, availability, and impact on ridership during the recommendation process. This appointment will replace the late Barbra Armentrout, who served the Rate Commission from 2017 until her recent passing. The term is to expire on June 30, 2025. **PASSED OUT OF THE COMMITTEE ON BUDGET** (04/02/2024) for adoption at April full Council meeting (04/17/2024).

**RESO 24-64**: Authorizing the use of overt video monitoring in the City and County of Honolulu at Scenic Points in East Oʻahu. The resolution's objective is to address the alarming criminal activities at the scenic lookouts in East Oʻahu, which include Makapu'u Point Lighthouse, Kaiwi State Scenic Shoreline trails, and Hālona Blowhole. These sites attract both residents and visitors, but unfortunately, they have also drawn criminal activities, particularly vehicle breakins. In 2023, 225 vehicle break-ins were reported at East Oʻahu lookouts. As a solution, the Honolulu Police Department (HPD) has proposed a pilot program that will deploy portable surveillance trailers. These trailers will be equipped with surveillance cameras, speakers, and a blue light mounted on a mast, similar to those seen in grocery store parking lots around the island. Installing portable surveillance trailers will be a crucial tool for HPD to ensure public safety. **SCHEDULED FOR PUBLIC HEARING** at April full Council meeting (04/17/2024) and

### How do I find out when the public meetings scheduled to hear the measures?

The City's Annual Budget Process takes place from March to June. Electronic agendas are posted on the Honolulu Record Collections page (HNL **DOCS**). Additionally, hard-copy agendas are posted for viewing at Honolulu Hale.

### How do I submit public testimony on any of the budget measures?

Citizens have multiple ways by which they may voice their opinions, as follows:

 Provide written or register to testify orally on the individual budget measures at the scheduled public meeting using the online Council Testimony Form available at https://hnldoc.ehawaii.gov/hnldoc/testimony.

### How do I find out if a project in my neighborhood, such as a skate park, has been included in the budget?

The budget measures, specifically the CIP budget bill, will provide a list of proposed projects. If you are unable to locate a specific project in the CIP bill, you may contact your Councilmember.



### **HOW TO SUBMIT TESTIMONY**

Submitting testimony to the Council is the best way to share your mana'o and impact important decisions. All testimony is collected for use during the public hearing process. Therefore, all testimony is public information.

### **Submit Written Testimony Online**

- 1) Visit www.honolulu.gov/ccl-testimony-form.
- 2) Include your first and last name, phone number, and email address.
- 3) Select the appropriate meeting date and Council/Public Hearing Committee in which the measure will be heard. The meeting calendar and agendas are provided on

### www.honolulucitycouncil.org.

- 4) Enter the Agenda Item. This is the measure you wish to testify on (a bill or resolution number).
- 5) Select your position on the measure:

Support/Oppose/Comment.

- 6) Indicate whether you are testifying as yourself or an organization.
- 7) Type in your written testimony or attach it as a .doc or .pdf.
- 8) Review for accuracy, then submit!

### **Submit Oral Testimony Online**

People may submit oral testimony remotely through the Zoom video conferencing platform.

- 1) A Zoom link and meeting number will be provided on the meeting agenda and posted six days before the Council Meeting or Committee Hearing.
- 2) To register, visit <a href="www.zoom.us">www.zoom.us</a>, click "Join a Meeting," and enter the meeting ID number. You will be taken to a form where you can complete the registration process.
- 3) You, as a registrant, will receive an email that contains links and information on joining the meeting by either phone or video conference.
- 4) Remote testimony will be taken at the start of the agenda and then closed. Each speaker is allowed to:
  - a. A three-minute presentation on Public Hearing, New Business, and Sunshine items; and
  - b. A one-minute presentation on all other items.
- 5) If you are testifying through Zoom, you are strongly encouraged to register at least 24 hours before the start of the meeting.



### **BEST PRACTICES**

You must testify on behalf of yourself, or on behalf of an organization.

Speak from the heart. Share your personal reasons for why you are testifying and how the agenda item up for discussion impacts you.

Come prepared with talking points that are clear, concise and right to the point of your goal.

Time yourself presenting your oral testimony to ensure that you are speaking within the allotted time given!
