
The City Council passed the annual budget on June 7th. Mayor Blangiardi signed the \$4.75B Capital & Operating budgets later in the month, which included a \$350 tax credit for homeowner occupants as well as a focus on affordable housing, public infrastructure, community revitalization, & public safety. Funding was also included for an affordable & workforce housing plan, l& acquisitions, & affordable housing & homeless service facilities. Public safety was also a focus, with funding going to community policing teams, speed trailers, & programs like Community Outreach Courts, Weed & Seed, & Waikīkī Safe & Sound. Funding for contracts relating to controlling feral chickens & other invasive birds was also information included. ATTENTION PARK USERS: DPR CONSIDERING NEW RULES REGARDING PARK COURTS.
PLEASE BE AWARE OF DRASTIC CHANGES. INPUT REQUESTED IMMEDIATELY

Survey open until July 21, 2023 at 4:30 pm (HST)

As part of the continuing effort to gather the community's input regarding existing conditions at City parks, the Honolulu Department of Parks and Recreation (DPR) is conducting a final survey to gauge public sentiment for proposed rules governing City park outdoor courts. This includes basketball, pickleball, tennis, and volleyball courts. A draft copy of the proposed rules may be accessed by following this link: <a href="mailto:bit.ly/DraftCourtRules">bit.ly/DraftCourtRules</a>.

The survey should only take a few minutes to complete and can be accessed online by visiting <a href="mailto:bit.ly/OutdoorCourtSurvey">bit.ly/OutdoorCourtSurvey</a>. The survey is open until 4:30 p.m. (HST) on Friday, July 21, 2023. Additional comments on the draft rules can be sent to <a href="mailto:DPRPMRSMail@honolulu.gov">DPRPMRSMail@honolulu.gov</a> and must be received before the closing of the survey mentioned above. Upon completing this final public survey, DPR will review the public comments before beginning the final stage of approval through the DPR formal rule promulgation process. This includes posting the final draft publicly and a public hearing for final public input. That hearing is expected this year.

The proposed rules aim to balance casual recreation use of the courts with the addition of tennis and pickleball lessons and other permitted activities. The hope is to have consistent, fair regulations on agreeable terms for all court users to encourage compliance and reduce the need for enforcement. We want to keep our facilities as open to recreational use as possible while allowing instructors to provide higher-quality lessons to our communities. #### **Chicken Noise Complaints**



In an effort to eradicate feral chickens & roosters from City & County of Honolulu properties, the Department of Customer Services has recently established a Feral Chicken Management Master Agreement with Sandwich Isles Pest Solutions. Feral chickens have been a source of early morning noise, thus causing a disturbance for neighboring communities. Moreover, roaming feral chicken waste can pose a health risk. As a resident, we ask that you please refrain from feeding feral chickens so that we can reduce their population. Sandwich Isles Pest Solutions have been removing feral chickens from several areas, including Koko Head District Park, the Honolulu Zoo, & Mau'umae Park. If you have any complaints about feral chickens on City & County of Honolulu properties, please send them to complaints@honolulu.gov or call (808) 768-4381. For complaints about chickens on private property, you may call the Honolulu Police Department 911 non-emergency if there is excessive noise or more than two chickens per household.

#### Kalākaua Ave Repaving & Curb Repair



Along Kalākaua Ave, the reconstruction of asphalt roads, concrete curbs, adjustment of manhole covers & utility boxes to surrounding grade levels, & the installation of vehicle detector loops began on June 15, 2023. The construction will last approximately 9 months. The repairs will be done along Kalākaua Ave from Olohana St to Monsarrat Ave; & Kalākaua Ave from the Dillingham Fountain to Poni Moi Rd. Contractors will work on the project in sections to facilitate the smooth movement of traffic & people. The contractor will also place "NO PARKING" signs along the sides of roadways one week before work starts to help notify the public of upcoming construction work areas. We kindly ask drivers to observe the dates & times of these notices, as vehicles parked on posted streets will be towed at the owner's expense. Although we would all like this project to be finished as soon as possible, please note that it is a construction site with many dangerous elements, such as new hot asphalt. To protect our community members, please be patient & proceed with caution when in the area. The Department of Design & Construction appreciates your understanding while we work to improve the roads in our community.

### DISTRICT IV UPDATES (CON'T)

City & County of Honolulu Skyline Gr& Opening June 30th



The rail transit system officially began operation at 2:00 pm on June 30, 2023. The transit system was also named Skyline because of the beautiful scenery that can be viewed when riding. The first phase stretches 11 miles between the Kualaka'i Station in East Kapolei & the Hālawa Station near Aloha Stadium. All rides on the new rail system were free for the opening weekend. Adult HOLO cards can be purchased at participating retailers, rail station kiosks, or TheBus Pass Office. Reduced fare programs are available at select locations for seniors, youth, Handi-Van riders, & those with low income, disabilities, or U.S. Medicare. The transit system is a big step towards the city's commitment to its Climate Action Plan.

## Hanauma Bay - No Reservation is Required for Kamaʻāina



Starting on Saturday, July 1, 2023, all Hawai'i residents (kama'āina) will be allowed into Hanauma Bay without making an online reservation. All they need to do is show a valid Hawai'i driver's license or school ID. The bay is open Wednesday through Sunday from 6:45 am until 1:30 pm, closes at 4:00 pm, & the beaches are cleared half an hour before that. Hanauma Bay is closed all day on Mondays & Tuesdays. Nevertheless, all visitors, including residents, must watch the educational & safety video before entering the beach. Also, consider that there are a limited 280 parking stalls at Hanauma Bay, so please be aware of that when visiting. The City encourages residents & visitors to see this historically significant location.

# COUNCIL PASSES TWO MEASURES PROVIDING TAX RELIEF FOR HOMEOWNERS AND KŪPUNA

HONOLULU, HAWAI'I - In a significant stride toward providing residents with real property tax relief, the Honolulu City Council has passed Bills 37 (2022) and 40 (2022). Bill 37 increases the threshold income level for the tax credit from \$60,000 to \$80,000. Bill 40 raises the homeowners and kūpuna exemptions by \$20,000 each, raising it to \$120,000 and \$160,000 respectively. The new laws are designed to provide substantial tax relief to homeowners, particularly the most vulnerable.

Council Vice Chair Esther Kia 'āina, who introduced these measures, said "We are committed to creating a fair and equitable tax structure that eases the burden on homeowners and our most vulnerable residents, while ensuring we have the funds needed to provide essential city services. These measures account for inflation and increased cost of living and represent a key step toward providing meaningful relief for our residents."

Council Chair Waters echoed these sentiments, and added, "As a Council, we have prioritized real property tax relief to ensure our local people are not priced out of our island home. Additionally, while changing the law is crucial, ensuring that homeowners have the information they need to apply is equally as important. By passing these measures today, the City will be able to include information on these tax relief measures in the annual assessments, so homeowners will be notified well in advance of the September 30 deadline."

Bill 37 provides a real property tax credit for homeowners whose property tax exceeds 3% of their income. To qualify for the tax credit, the combined income of all titleholders for the property must not exceed \$80,000, and the homeowner must file for the credit by September 30, 2023.

Bill 40 increases the exemption amount from \$100,000 to \$120,000 for homeowners, and \$140,000 to \$160,000 for kūpuna. To qualify for this tax exemption, residents must file for their homeowners exemption by September 30, 2023.

Councimember Okimoto voiced her support, stating, "These measures aren't just changes on paper, they are tangible steps toward fairness and relief for our homeowners. We have heard the voices of our constituents, and we recognize the need for real property tax relief. These are much-needed changes that will bring significant relief to many households that call O 'ahu home."

Councilmember Dos Santos-Tam added to the discussion, "In addition to the tax relief benefits, I believe the bill provided us an opportunity to continue the important work of updating the language of our City Ordinances. In our commitment to inclusivity, we included language amendments that would

acknowledge and respect all marriage structures and guarantee equitable access to benefits for all married couples. It is a small but significant change that affirms our dedication to equity and ensures that the language enshrined in our laws better represents our diverse communities."

Kia ʿāina represents City Council District 3, which includes ʿĀhuimanu, He ʻeia, Ha ʻikū, Kāne ʻohe, Maunawili, Kailua, Olomana, Enchanted Lake and Waimānalo.

Waters represents City Council District 4, which includes Hawai'i Kai, Kuli'ou'ou, Niu Valley, 'Āina Haina, Wailupe, Wai'alae Iki, Kalani Valley, Kāhala, Wilhelmina Rise, Kaimukī, Kapahulu, Diamond Head, and Waikīkī.

Dos Santos-Tam represents City Council District 6, which spans from Kakaʻako to Kalihi, and includes portions of Kakaʻako, Chinatown, Downtown, Punchbowl, Papakōlea, Pauoa Valley, Nuʻuanu, Iwilei, Liliha, 'Ālewa Heights, Kalihi and Kalihi Valley.

Okimoto represents City Council District 8, which includes portions of 'Aiea, Waimalu, Newtown, Pearl City, Seaview, Crestview, Waipi'o Gentry, Koa Ridge, Mililani Town, and Mililani Mauka.
