

City Administration Releases Council Approved \$1.3 Million for More Lifeguards



The Council approved over \$1.3 million in this year's budget for 16 additional lifeguards, and I am happy to report that the Administration has created those positions, enabling Ocean Safety to support extended lifeguard services as mandated by law. This is especially important as we gear up for the winter surf season, which brings hazardous conditions and an increase in beachgoers to the west and north-facing shores. With the additional positions, Ocean Safety will be able to start a recruiting class next month, which includes emergency medical responder training, orientation to the rescue jet ski, a course in emergency vehicle driving, near-shore rescue techniques, and practical skills in saving conscious and unconscious patients from the shoreline. This is excellent news for public safety at beach parks, as data shows a dramatically improved safety posture, particularly during the busiest time of the day at some popular beaches. DISTRICT 4 UPDATES

Legislative Review Executive Management Committee:

We discussed Resolution 23-207, which I introduced to require inspections of Waikīkī shoreline hotels. This is important for our island as we face climate change and sea level rise. We listened to different stakeholders who shared their views on the inspections and the environmental impacts. Some of them wanted more frequent inspections. We also learned about a new project called "Adapt Waikīkī 2050", which will study the effects of climate change and sea level rise in Waikīkī and plan long-term infrastructure adaptation. This is an excellent chance for us to work with DPP, other city agencies, community members, experts, and hotel owners to find solutions for Waikīkī.

Planning and the Economy Committee:

The Department of Planning and Permitting updated the building Committee on the permit (https://hnldoc.ehawaii.gov/hnldoc/document-download? id=19260). Excluding instant online building permits, the residential permit duration has been reduced from 330 days to 181 days during the last year. Pre-screening improved from 6 months to 5 days. Code Review increased from 3 months to 5 months and 3 weeks. The approvals to issue permits have been reduced from 2 months to 5 days. DPP Director Apuna said she is working hard with her department to bring these numbers down even more. Commercial permits decreased from 420 to 352 days, with Code Review as the main problem. DPP has hired 76 new employees and has lost 41 staff members due to retirement and other separations, resulting in a net gain of 35 personnel. DPP created 15 Plans Examining Engineer positions, and they believe that hiring these professionally licensed workers will reduce building permit backlog for residential and commercial permits. The City is looking for ways to get more applicants to work at the DPP and speed up the permit process.

Honoring and Recognizing Assets School during Dyslexia Awareness Month in Hawai'i



The Honolulu City Council recognized Assets School in October for its outstanding service in educating students with dyslexia, language-based learning differences, and gifted students. As the only school in Hawai'i dedicated to this task, Assets School has been providing excellent education for over 60 years, operating on two campuses in Honolulu. Their tailored curriculum prioritizes students' strengths to help them overcome their learning differences, and their inclusive community fosters a sense of belonging, acceptance, and support. The Honolulu City Council presented Assets School with an Honorary Certificate in recognition of their exceptional services during Dyslexia Awareness Month and sends its warmest aloha and best wishes for the school's continued success in creating a more inclusive and supportive community for those with dyslexia in Hawai'i.

Hawaiʻi American Water Hawaiʻi Kai Traffic Alert



Hawai'i American Water will reconstruct their Wastewater Pump Station #2, located at 546 Kawaihae Street, beginning in January 2024. This private wastewater improvement project is expected to last about ten months and will impact traffic on Kawaihae Street. This station was initially constructed in the early 1960s and needs to be modernized to optimize operational efficiency and safety. The work includes taking the current pump station out of service and temporarily replacing it with two portable pumps that will be placed on the street adjacent to the station, along with safety barriers. Unfortunately, this will require residents on the makai side of Kawaihae Street fronting these barriers to travel in the Koko Head direction. Those residents on the mauka side of Kawaihae Street must travel in the Diamond Head direction. Residents and motorists should also anticipate intermittent sidewalks and lane closures on the mauka side of the street as the work continues. For safety reasons, on-street parking will also be prohibited near the safety barriers.

Informational project packets were distributed to all the homes on Hakalau Place and along Kawaihae Street from the corner of Hakalau Place to Hawaii Kai Drive.
