Proposed Game Room Legislation to be Introduced This Month



This month, CM Dos Santos-Tam will propose legislation with CM Andria Tupola involving illegal game rooms. Our two districts have the most illegal game rooms, which affects our communities. Often the presence of game rooms invites other forms of unwanted or illicit behavior such as gambling, drug distribution, vandalism, litter, noise, and loitering One bill will be related to **public nuisance**, specifically that property owners - the game rooms' landlords - would be obligated to keep their property free from unsafe conditions that harm or threaten the welfare of the public. If an illegal game room is occurring on the premises the owner is responsible, and will pay civil fines. The next is a bill that would permit **authorized DPP, HPD, and other City personnel** to enforce certain provisions of the building and construction code. Only authorized personnel can serve notice of violation or order to the responsible party to compel them

into compliance usually through civil fines. The final is a **resolution on coordination**, imploring numerous City departments designated to enforce City building, fire, and zoning codes to work with the Honolulu Police Dept . (HPD) to gather and streamline evidence of such violations, particularly when illegal game rooms are suspected.

Bill 40: Transit Construction Mitigation Fund

<u>Bill 40 (23)</u> is a bill that CM Dos Santos-Tam and CM Cordero have introduced which would give the department of Budget and Fiscal Services (BFS) additional requirements to abide by when administering the Transit Construction Mitigation Fund. The purpose of the is to assist businesses experiencing revenue loss during rail construction along the Dillingham Corridor. Our office is working with other City departments to create a system in which a form of relief can be made available for those affected businesses. The bill is moving on to Second Reading.





Bill on Monster Home False Statements Moves Ahead

CM Dos Santos-Tam introduced <u>Bill 44 (23)</u> earlier this year to deter people from making or inciting the making of a false statement to a city official. At the August meeting of the Executive Matters and Legal Affairs committee, which he chairs, the bill was amended to specifically move the language into the "building permit" section of the Revised Ordinances of Honolulu. The bill created criteria for someone to be labeled as having a "history of making false statements," and at the next committee

meeting, members will be deciding on the penalties for people who habitually make false statements. These penalties may include higher fines, demolition, or a prohibition on submitting new building permit applications for a certain amount of time.

Bill 4: Energy Conservation Legislation Signed Into Law

Mayor Rick Blangiardi signed <u>Bill 4 (23)</u> into law as Ordinance 23-25 that updates and improves the City's Building Energy Conservation Code. Energy codes establish minimum energy performance requirements for new residential and commercial buildings. The codes provide protection as temperatures rise causing potential health heat risks, while delivering energy savings, lower utility bills, and reducing the environmental impacts of O'ahu's building stock. After the state adopted the 2018 International Energy Conservation Code in December 2020, the City had the opportunity to adopt the state's code, with its own local amendments. Local amendments were developed in close coordination with industry experts, such as the American Institute of Architects and the Building Industry Association of Hawai'i, to ensure code requirements match O'ahu's specific market needs and context. The City looks forward to partnering with industry stakeholders to create innovative and sustainable policies.

5-Way Stop Proposal at Prospect Intersection Closer to Fruition

DTS announced their proposal for a five-way stop at the intersection of Prospect/'Iolani/Alapa'i to address speeding, limited line-of-sight issues, and hazards for pedestrians. DTS has also explored other options, including the possibility of a "round-about" configuration. We welcome your opinions on these proposals as residents, pedestrians, and drivers in the area. CM Dos Santos-Tam also successfully added funding in the 2023-24 City Budget to erect an interactive speed monitoring sign near the intersection as well to monitor driver speed on the 'Iolani Ave hill. CM Dos Santos-Tam is committed to resolving this long-standing safety issue in the community.





New "Higher Fines" Signs Coming Soon to Kapālama ES

By request of concerned community members our office was able to send in a request to the Department of Transportation to install "Higher Fines" signs on Bernice Street and School Street within the Kapālama Elementary School Zone. The signage allows police officers to enforce higher fines at over \$200 on top of the base ticket. The signage will help serve as a deterrent to speeding drivers, helping to improve road safety for other drives and pedestrians. Careless drivers often speed in this area as they try to bypass Likelike Hwy traffic.

Papakōlea Neighbors Come Together for Donation Drive for Maui

Kula no na Po'e Hawai'i - Papakōlea hosted a donation drop-off at Lincoln Elementary on the weekend after the tragic Maui fires to support Hui No Ke Ola Pono, the Native Hawaiian Health Care System on Maui and to support the greater Maui community through the County of Maui and Papa Ola Lokahi. The group collected food, kūpuna and keiki supplies, clothing, shoes, and other goods which were immediately needed on Maui. CM Dos Santos-Tam helped the group set up the donation stations, and encourages community members to continue supporting Maui relief efforts.

Foster Botanical Garden Reopened after Months-Long Renovation

Adding new accessible plots to the community garden. Installing a replacement drinking fountain and upgrading the garden's various pathways. Work Begins to Repair Problematic Richard Lane Sewage Leak



CM Dos Santos-Tam has been working with Kalihi neighbors living on Richard Lane to try to resolve the constant sewage leaks that have been happening under their driveway for years. The contaminated water drains into the street where residents and children have to avoid stepping or driving in when coming and going from their homes. CM Dos Santos-Tam has been working to determine who exactly are the owners are of this driveway off Richard Lane and to make sure that the various government agencies involved like the State Dept of Health (DOH), the City's Dept of Planning and Permitting (DPP), and Dept of Environmental Services (ENV) are being proactive partners. A privately-contracted plumbing company recently began repair work that will hopefully put a stop to the ongoing sewer leak once and for all.


Chinatown Cameras Installed, More To Come

Various City departments, including Department of Information and Technology (DIT), Department of Facility Maintenance (DFM), Department of Transportation (DTS) and the Honolulu Police Department (HPD) worked to install new Chinatown cameras on several street light poles in Chinatown, and more are coming soon. The cameras, which operate 24/7, are connected to HPD's Chinatown substation so officers can monitor multiple cameras at a time. Footage is retained for 30 days in case it is needed to help resolve criminal cases. In addition to a new camera on the Chinatown substation, cameras were installed so far at Hotel/Maunakea; Hotel/Kekaulike; River/Hotel; River/Pauahi; Pauahi/Public Restrooms; Pauahi/Maunakea; and at Pauahi/Smith St.

Draft Revisions to Primary Urban Center Development Plan Coming Soon

The role of the Primary Urban Center Development Plan (PUC DP) is to implement the comprehensive vision of the O'ahu General Plan through policies and guidelines that reflect the unique conditions, geography, and concerns of the Primary Urban Center. The City Council will refers to its policies for guidance when making important decisions regarding land use and development, such as rezoning or discretionary project approvals. A revised PUC DP proposal will be coming up in the fall for public review, and we encourage community members to provide their input once the draft is put forward.

Hawai'i Fire Relief Housing Program Opens to Assist Maui Residents

As a result of the tragic Maui wildfire last month, thousands of people are displaced and in need of housing. Government and non government organizations have mobilized to fulfill the needs of the community. The Hawaii Fire Relief Housing Program is a State run program by the Department of Business, Economic Development & Tourism. The goal of the program is to connect those in urgent need of housing, with Hawai'i homeowners willing to assist by offering unoccupied rooms, units or houses on a temporary basis to individuals and families affected by the fires.
