Honolulu Skyline Has Historic Opening Weekend

On June 30th, the Honolulu Rail Transit Project, now dubbed "Skyline," entered into service, fulfilling decades of efforts to build a mass transit alternative from West O'ahu into Honolulu. Residents from all over the island came to experience the system's first phase, which had been under construction for over a decade. Riders were able to go from the Hālawa Station to Kualaka'i Station in East Kapolei. For commuters, the public transit system is integrated so now riders can utilize both TheBus and Skyline effortlessly through the HOLO card system. Starting July 1, TheBus service and routes will be updated to include access to the first nine Skyline stations. This expansion aims to provide commuters with increased accessibility and flexibility when planning their day. Skyline requires an active HOLO card loaded with funds to board. HOLO card vending machines will also be located at the entrance to

each station, or they can be purchased at supermarkets around the island. HOLO cards can be managed online at <u>holocard.net</u>. As a frequent public transit rider himself, CM Dos Santos-Tam is excited to have Skyline available to O'ahu residents and visitors!

New City Initiative Shuts Down Two Kalihi Game Rooms



CM Dos Santos-Tam is passionate about closing illegal game rooms. Often game rooms invite other illicit activities in the area such as gambling, drug distribution, prostitution, and gun violence. CM Dos Santos-Tam has been working with HPD and a number of other City agencies to crack down on landowners whose property is being used as a game room. Recently, the "Ohana Grocery" game room at the corner of Pālama St and Kanoa St was shut down, and shortly thereafter, the owners of the property at 2101 Wilson St in Kalihi evicted the tenant who was operating a game room on their property. The owners also ripped out all of the the electrical wires servicing the game room machines. Our office will continue to focus on collaborating on DPP, HPD, and the Prosecutor's Office on reducing the number of game rooms in the community.

Bill 20: Restricted Parking Zones (RPZ)

The bill introduced in March by CM Dos Santos-Tam to establish Restricted Parking Zones (RPZ) island wide is progressing through City Council. However, in a Transportation Committee meeting on June 20th the Department of Transportation Services (DTS) requested the bill be deferred for a month in order for the department to have more time to work on further amendments. Our office sent a letter to DTS requesting that they provide the Transportation Committee members more information such as the base rate recommendation of the fee, the financial justification for the base rate recommendation, and a summary of the number of parking permits per household in the current RPZ pilot program. As Chair of the Transportation Committee, it is our intent to hold a hearing on Bill 20 (2023) at the July Transportation Committee meeting so it can have final approval at the Full Council meeting on Wednesday, August 9th.

Bill 28: Cutting Down on Drug Overdoses CM Dos Santos-Tam introduced Bill 28 which would require bars and nightclubs to have

doses of the anti-opioid spray naloxone, also called "Narcan" on premises. Because alcohol can interact with opioids in someone's system, these venues are places where there is a higher risk of a deadly overdose. "Narcan" was recently approved by the FDA for over-thecounter sales, and Councilmember Dos Santos-Tam is now working with the State Department of Health, the City's Liquor Commission, and private groups like HHHRC to

make the the required prevention doses available for free to bar and nightclub owners. This is a measure to protect public health and also to get "ahead of the curve'. What has to be diecided is who is the official primary enforcer of the measure. CM Dos Santos-Tam is working with other City officials to find solutions to help reduce the number of fatal opiod overdoses in Hawaii. The bill is on its way to Third Reading.

Bill 32: Adopting New Rules to Safely Ride Skyline CM Dos Santos-Tam introduced Bill 32 (23) relating to public transit. The legislation allows for limited

advertising inside rail, so the City can begin offsetting the costs of operations. It specifies that City payment cards ("HOLO cards") are accepted on all modes throughout the transit system, including Skyline and TheBus. A voucher program is established where employers can incentivize their employees to use Skyline and TheBus. The rules allow the Department of Transportation Services (DTS) to implement a policing plan for the city transit system, to maximize public safely on Skyline and TheBus. to help ensure comfort and public safety, it bans the use of vapes on Skyline and TheBus and any disruptive behavior that may threaten or harm passengers or rail operators. The Chief of 🛭 Police to commission officers, special officers, and contracted security officers can cite passengers for inappropriate behavior, such as public intoxication or harassment. It also allows for a reduced annual pass fare of \$45.00 for "extremely low income" individuals.

Upcoming Gameroom Legislation
CM Dos Santos-Tam and his staff will propose legislation to address public nuisance related gambling activities that are on the rise around the island. CM hopes to reduce illegal game rooms through the use of nuisance abatement. This is the stoppage of that which causes the nuisance, which is specifically, illegal gambling establishments. According to Honolulu Police Department (HPD) there are currently about 100 operational game rooms on the island. Our office will be collaborating with Councilmember Andria Tupola to create pieces of legislation that will approach the issue from different angles. There are indications if a building could be hosting illegal gambling operations such as large locks on the doors, no obvious business signage.

Second Kaka'ako General Managers and Board Presidents Meeting Held

CM Dos Santos-Tam, along with our state partners Speaker Scott Saiki and Senator Sharon Moriwaki, convened the second meeting on the Kaka'ako-area condo general managers and owners' association presidents to discuss issues that Kaka'ako residents experience on a daily basis. Major discussion topics included how to connect homeless individuals with resources to help reduce vagrancy, as well as how to prevent crime and drug use in the community. New development projects in the area that might disrupt traffic and pedestrians. were also discussed, along with concerns about feral chicken and cat populations in area parks. As the Kaka'ako area legislators, we are committed to continuing to dialogue with the general managers, condo associations, and area residents to improve this quickly-growing and changing area!

As a reminder, the Kaka'ako Citizens Patrol meets every Monday from 5:15-6:15 p.m., starting at the Cooke and Halekauwila St corner of Mother Waldron Park.

City Budget Accomplishments for District 6

Our office is committed to fighting for District 6's priorities. The investments we make in our community will improve the district for everyone. Specific budget highlights include:

- \$1,350,000 for sidewalk repairs and bikeway improvements;
- \$220,000 to increase salaries for 9-1-1 dispatchers;
- \$450,000 for additional pedestrian safety projects;
- \$100,000 for crosswalk improvements:
- \$300,000 for improvements to address the large homeless encampment on Kanoa St in Pālama;
- \$150,000 for solar speed signs, including at the intersection of Prospect St and Alapai Street;
- \$400,000 to continue funding for the Chinatown Task Force;
- \$15,000 for a speed trailer for the Honolulu Police Department; and
- \$250,000 to construct bathrooms in Chinatown parks.

Five-way Stop Proposed for Prospect-'Iolani-Alapa'i Intersection

The intersection of Prospect St, Alapa'i St, and 'lolani Ave has been recognized as a dangerous intersection for many years, with a long history of accidents and near-misses. In January 2023, a fatal accident involving a speeding drunk driver claimed the life of a local resident and catalyzed community demands for safety improvements. In response, CM Dos Santos-Tam convened a meeting in early April with area residents, neighborhood board members, HPD, and the City Dept. of Transportation

Services (DTS) to evaluate possible fixes. At the June meeting of the Makiki/Lower Punchbowl/Tantalus Neighborhood Board,

DTS announced their proposal for a five-way stop at the intersection to address speeding, limited line-of-sight issues, and hazards for pedestrians. DTS has also explored other options, including the possibility of a "round-about" configuration. We welcome your opinions on these proposals as residents, pedestrians, and drivers in the area. Councilmember Dos Santos-Tam also successfully added funding in the 2023-24 City Budget to erect an interactive speed monitoring sign near the intersection as well to monitor driver speed on the 'Iolani Ave hill. CM Dos Santos-Tam is committed to resolving this long-standing safety issue in the community.

New 'Auwaiolimu Street Striping Coming Soon



After many concerns about speeding, pedestrian safety, and traffic flow during the peak rush hour period on 'Auwaiolimu St, the City is planning to add additional striping along the entire stretch of this roadway, replace the many faded signs in the area, and reduce the speed limit to 25MPH on the "Pauoa side" of 'Auwaiolimu St. Because 'Auwaiolimu is often viewed as a "shortcut" around the back side of Pūowaina Crater, many drivers treat it as a speedway, which is a hazard to the residents in the area and the many students our office has also requested additional speeding en-

forcement in this area from HPD and we successfully added a line item to the FY2023-24 budget to acquire a digital speed monitoring trailer for this part of our district.

Kalihi Neighbors Mobilize to Resolve Sewer Leak on Richard Lane





The neighbors in the Kalihi area living on Richard Lane, have been experiencing constant sewage leaks for years. The contaminated water drains into the street where residents and children have to avoid stepping or driving in when coming and going from their homes. CM Dos Santos-Tam is working to determine who the owners are of this driveway off Richard Lane and who is responsible for fixing the problem. The State Department of Health (DOH), the City's Department of Planning and Permitting (DPP), and Department of Environmental Services (ENV) are in communications to help with this ongoing public health hazard that residents are being exposed to everyday.

Bernice Street, which runs between Bishop Museum and the school, is a hotspot for speeders as it's seen as a shortcut to avoid the Likelike Hwy stoplight.

Mizuno/TDST Hold Joint City-State Workshop on Albizia

CM Dos Santos-Tam and State Representative John Mizuno held a workshop at St. Anthony Retreat Center Saturday, June 24th to help educate residents about Albizia trees, improve safety, and address how to slow the proliferation of the tree in the district. Many residents in the area joined to learn how to identify, asses, and remove Albizia trees on their



property and throughout their neighborhood. Albizia trees are considered a high-risk invasive species, creating a safety hazard for residents and community infrastructure. The trees can grow rapidly in the first five years, making branches large and brittle. The sudden drop of branches causes impacts to roads, homes, powerlines, and culverts.
